The Chair of the School of Physical Therapy (Program Chair) serves to provide leadership, management and planning for the School of Physical Therapy in accordance with University policy and CAPTE standards. The Chair will teach within an area of expertise and foster collaboration among the academic units within the College of Health Sciences in order to create a multi-disciplinary approach to professional health care education.

The School of Physical Therapy consists of nine full-time faculty members recognized nationally and internationally for their clinical expertise, professional service and research achievements. The School of Physical Therapy offers a three year, Doctorate of Physical Therapy (DPT) degree program that received initial accreditation from CAPTE in May 2000.

Description:

- Hold an earned post-professional academic doctoral degree.
- Must be eligible for a full-time (12 month) appointment at the academic rank of Associate Professor or above and have a record of scholarly activity, teaching, and service that would qualify for tenure.
- A minimum of ten (10) years of experience as a practicing physical therapist.
- A minimum of six (6) years of experience with a full-time teaching appointment.
- Prior success in administration and management.
- Prior successes with research grant submissions.
- Understanding of and experience with physical therapy curriculum content, design and evaluation.
- Understanding of CAPTE and experience with the accreditation process.
- Understanding of residency education
- Philosophically aligned with serving in a Christian community of learning and service.

Qualities: The Department Chair is expected to be a leader that is able to motivate and provide strategic leadership to the staff and faculty of the School, and serve as a key member of the College of Health Sciences and Nursing Team. Traits required of the successful applicant include character, integrity and vision of the evolving nature of professional physical therapy education.
