The Department of Physical Therapy at Wingate University invites applications for a 12-month, full-time Academic Coordinator/Director of Clinical Education (ACCE/DCE) available beginning June 1, 2018. The ACCE/DCE holds a faculty appointment commensurate with qualifications and experience (Assistant, Associate, or Full Professor) and has administrative, teaching, service, and scholarship responsibilities consistent with the mission and philosophy of Wingate University.

Responsibilities include:

- (1) Developing, monitoring, and refining the clinical education component of the curriculum
 - (2) Facilitating quality learning experiences for students during clinical education
 - (3) Establishing, developing, and maintaining an adequate number of clinical education sites relative to quality, quantity, and diversity of learning experiences (i.e., continuum of care, commonly seen diagnoses, across the lifespan, health care delivery systems, payers, cultural competency issues) to meet the educational needs of students and the academic program, the philosophy and outcomes of the program, and evaluative criteria set by CAPTE
 - (4) Establishing standards and evaluating clinical education sites
 - (5) Placing, supervising, and communicating with students while on clinical experiences
 - (6) Monitoring and documenting the academic performance of students to ensure that they successfully achieve the criteria for completing clinical learning experiences
 - (7) Confering with the appropriate faculty, the Program Director, Dean, Administration, and other individuals where applicable
 - (8) Managing administrative responsibilities consistent with CAPTE, federal/state regulations, institutional policy, and practice setting requirements.
 - (9) Collaborating with clinical faculty to promote, coordinate, plan, and provide clinical faculty development opportunities
 - (10) Maintaining knowledge of current trends in health care and its effect on clinical education and apprising clinical educators and faculty of any changing trends
- Coordinating or providing leadership for a Clinical Education or Program Advisory Committee consisting of area clinical coordinators, employers, or other persons
- (11) Minimal teaching in the entry-level DPT curriculum
 - (12) Scholarship and service to the Department, University, and community

Description:

The innovative student-centered DPT program at Wingate University has a clear focus on a team-based highly integrated curriculum that develops every student to their fullest potential. The program is housed in a state-of-the-art facility in the center of campus with easy access to the student center, library, athletic facilities and student services. Facilities include newly renovated classrooms, faculty offices, instructional laboratories, lounge & study areas, research labs, faculty work space, and a 10 cadaver dissection laboratory. The department currently has 11 full-time faculty members, each highly respected in their fields and recognized as experts in education, scholarship and professional service.
