Teaching responsibilities will involve team-teaching in the lifespan course, as well as in other courses where pediatric content is integrated in our Doctor of Physical Therapy (DPT) curriculum. The position also includes DPT student advising, scholarship, and service on departmental committees. This position is being offered at the assistant or associate professor level. Salary is negotiable. Ideal applicants will hold an earned doctorate (PhD, DPT, EdD, DSc) in Physical Therapy, Kinesiology, Biomechanics, Developmental Disabilities, Motor Learning, or a related discipline, as well as be a pediatric clinical specialist (PCS).

Description: The preferred applicant should have a record in teaching, clinical research and accompanying scholarly productivity in the area of pediatrics. The teaching and research environments at Northwestern University are exceptionally strong, with opportunities for interactions with faculty in additional departments including the Departments of Pediatrics, Neurology, PM&R, and Orthopedic Surgery. Appointments at the rank of Assistant Professor or Associate Professor will be considered. Salary is commensurate with experience.
