The Tufts University School of Medicine's Department of Public Health and Community Medicine invites applications for a full-time faculty appointment at the level of Instructor/Assistant Professor as Director of Clinical Education for the Doctor of Physical Therapy Program.

The Director of Clinical Education is responsible for developing, monitoring and refining the clinical education component of the curriculum. Facilitates quality learning experiences for students during clinical education. Evaluates students' performance in cooperation with other faculty to determine their ability to integrate didactic and clinical learning experiences and to progress within the curriculum. Educates students, clinical and academic faculty about clinical education. Selects clinical learning environments that demonstrate characteristics of sound patient/client management, ethical and professional behavior, and currency with physical therapy practice. Maximizes available resources for the clinical education program. Provides documented records and assessment of the clinical education component (includes clinical education sites, clinical educators, etc.). Actively engages core faculty clinical education planning, implementation, and assessment. In cooperation with other academic faculty, establishes clinical education site and facility standards, selects and evaluates clinical education sites, and facilitates ongoing development of and communication with clinical education sites and clinical faculty.

We seek a collegial individual who has a Doctor of Physical Therapy degree (or tDPT) with ABPTS specialization in a discipline appropriate for teaching responsibilities or a terminal academic doctorate in a discipline appropriate for teaching responsibilities.

This individual will have an understanding of higher education and contemporary clinical practice appropriate for leadership in physical therapy clinical education; knowledge of legislative, regulatory, legal, and practice issues affecting didactic and clinical education, students, and the profession of physical therapy; Licensed or eligible for licensure in Massachusetts or the state of residence; Active in clinical practice, especially as applicable to clinical education; and Active in professional activities at local, state, and/or national levels.

This is a non-tenured track faculty position with salary and rank commensurate with qualifications.
