Faculty responsibilities include teaching, scholarship, student academic/research advising, and service in the entry-level DPT program. The ideal candidate will have university teaching that enhances the department's teaching, scholarship, and service across a variety of settings.

1. Earned doctorate in physical therapy or related field (terminal degree).
2. Licensed or eligible for licensure as a Physical Therapist by State of Texas.
3. At least 5 years of clinical practice experience and recent/current clinical engagement if employed in an academic setting.
4. Experience in teaching the musculoskeletal system.
5. Demonstrated ability to establish a program of scholarship.
6. Record of accomplishments in scholarship, teaching, and service, appropriate for appointment at the rank of Assistant Professor (less than five years teaching), Associate Professor (minimum five years teaching), or Professor (minimum of 10 years teaching).
7. The successful applicant will receive the appropriate rank and title based on university and department established standards.
