Minutes

Meeting called to order at: 7:00 am CST/8:00 am EDT

- **Update from APTA**
CE SIG Working with APTA to obtain updates about PT and PTA CPI in preparation for CSM.
- **Update on letter for APTA Academy of Education Executive Committee**
Co-chairs Carol and Karen will be meeting with the APTA Academy of Education as a follow up to the strategic planning meeting they attended in September.
- **2022 Candidate Recruitment**
There has been interest expressed in the academic co-chair, membership secretary and nominating committee positions.
- **Ad hoc Outstanding Clinical Educator Award**
The Ad hoc Outstanding Clinical Educator Award committee is considering utilizing regional consortiums as a mechanism to nominate an outstanding clinical educator and site. Board is in support of this. Board recommends that the Awards Committee provide update to the chair of the Academy of Education Awards Committee to ensure the format is correct for the award.
- **Planning for CSM 2022 / Roundtable meeting**
The time for the business meeting has not been set yet. Board is exploring the possibility of hosting a CI networking event in conjunction with the business meeting.
- **Task Force Planning / Clinical Education Timeline and SCCE Resource Development**
The Board received good responses from the surveys distributed at ELC. There was a lot of interest in serving on a task force and/or sharing resources. The committee will contact those individuals who expressed interest.

Two task forces will be established. One will address the Clinical Education Timeline and the other will address SCCE Resource Development. The Board would like a balance between the academic

and clinical side for each of these. However, for the SCCE Resource Development taskforce, more SCCEs will be recruited. Each taskforce will also need to have a liaison from the Board.

- **ELP**

Vision report is complete. Now that vision document is done, the MOU for ELP will expire. This document outlines six areas we need to address in physical therapy education. The APTA Academy of Education and ACAPT will work together to address these areas. The report has not been formerly released to broader membership yet. The Board would like to see a joint statement from CESIG, NCCE, PTASIG pushing out ELP Vision document.

The Board will need to determine where SCCE Resource Development Taskforce, Clinical Education Timeline Taskforce, and CI Award fall within this document and Academy of Education Strategic Plan. It is important to align these efforts with the ELC Vision and APTA Academy of Education strategic plan.
