- I. Introductions –
 - a. Elsa Drevyn, recording sec. DCE from UM. Chair of the FCCE and secretary of FPTA. Has been secretary for SIG since last ELC.
 - b. Susan Tomlinson - Nominating committee DCE at Arcadia for 15 yrs. Academic director at large for NCCE. New to this role in SIG.
 - c. Angel Holland – Chair of nominating committee DCE university of Arkansas. 2nd year in this role for the SIG. She defended her dissertation in July. Just got an ADCE to assist her.
 - d. Lisa Harrison– membership sec. DCE at UT at Chattanooga. Half way through EdD. First year in this role in the SIG.
 - e. Jay Lamble- co-chair for clinical Works at Shirley Ryan Ability Lab. Clinician since 1986. Has been in co-chair role for a year.
 - f. Carol Beckel - Academic co-chair DCE at Saint. Louis University for 14 years. First year on the board. Had been a secretary of the SIG in the past.

We all need to fill out two forms. One is the COI form that needs to be filled out annually. This forms is a disclosure to see if you have any fiduciary interest in any of the hotels, etc. that we work with. The other one is the APTA code of conduct.

- II. Preparation for ELC – Saturday, October 13th, 8-10am. It is a time for the Academic and Clinical faculty to get together. Our official business meeting is at CSM.

Possible topics for Open Forum -

- a. Conflicts with NPTE early testing and Fellowship interviews

Time off for residency interviews and for NPTE testing is a problem at clinical sites with students missing so many days. Jay and Carol are in a task force that that is trying to generate a questionnaire about this. We would like someone from the residency board to attend our meeting so that we can hear everyone's perspectives. She has not had a response to this yet. SIGs seem to be scheduled at the same time.

Action item: Carol and Jay will find out and reach out to the NW intermountain consortium that brought up this issue at the last ELC. They generated a letter that was sent to the consortium and was endorsed by the CE SIG.

The students may be flying to these interviews and it is time consuming and expensive.

Could we contact a program in the Jacksonville area that may be sending students to ELC. We could then hear on this topic from a student's perspective? A new grad would be best. Brooks Rehabilitation also has a big presence in that area and has several residency programs.

Action item: Susan will contact Brooks and see if they can send someone.

Action item: Carol will contact a residency director and invite them to our meeting

Could we put questions in the HUB, regarding this topic, ahead of time so that we can prepare for this topic better?

- b. New CE terminology Let's reinforce this
 - c. Resource manual for site coordinators of clinical education. Let's bring this up again and remind them of the manual and how to access it. The APTE board would like to bring this back up for discussion to move this resource from a members only to open access for everyone.
 - d. Positions that will be open next Spring for the SIG are: Jay's position as clinical co-chair, Elsa's position as recording secretary and Angel's position in the nominating committee. We can run for a second term if we want. We can do a google document or something different for individuals who may be interested so that they can get information on the positions. We could also pass a form around at ELC for anyone interested to sign up. The deadline for submitting, if you are interested, is December 1st and we present the candidates in January. We could introduce the candidates at CSM.
 - e. CPI should we bring this up? There is a lot of frustration regarding this. The help center has not been answering questions effectively. One of the charges at ELC is to look at technology in clinical education. It may be time to look at alternatives to the CPI.

Background on ACAPT: was developed around '06. ACAPT was developed to address the education of PT students. The education academy is more inclusive because is PT and PTA. The NCCE is to inform the greater body of ACAPT. ACAPT was formed so that they are institutional members/programs, not individuals. ELP is trying to integrate all the players. Donna Applebaum wrote a paper on what she thought the roles of each entity should do.
